

Performance scenarios

The unfavourable scenario occurred for an investment between 03/2015 and 03/2020.

What happens if Vector Asset Management is unable to pay out?

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
